KITTSON COUNTY DITCH NO. 21 DIVERSION 1 IMPROVEMENT TWO RIVERS WATERSHED DISTRICT - HALLOCK, MN

Separate sealed bids for the furnishing of all labor, materials and equipment for the Improvement of Kittson County Ditch No. 21 - Diversion 1 will be received by the Two Rivers Watershed District, at their office in the Kittson County Courthouse, Hallock, Minnesota, until 8:00 a.m. on Friday, November 3, 2017 at which time and place they will be opened and read aloud.

The work to be done on this project "Kittson County Ditch No. 21 – Diversion 1", shall consist of the following estimated major items: Unclassified excavation (approximately 15,000 cubic yards), corrugated metal pipe installation, seeding and mulching.

Equipment used for excavation of the ditch shall be equipped with and use a GPS/GNSS guidance system corrected with RTK. The work on this project is required to be started within 10 days after the Notice to Proceed is given to the Contractor and such work is required to be completed by May 31, 2018. The bids will be awarded based upon the lowest responsible bid.

The project is to be paid for in cash. No bid will be considered unless sealed, filed with the Administrator and accompanied by a cash deposit, certified check, bid bond or cashier's check, payable to the Two Rivers Watershed District in the sum of at least ten (10) percent of the amount of the bid, such deposit or check or amount of Bidder's Bond to be forfeited to the watershed in the event that the successful bidder shall fail to enter into a contract awarded to him in accordance with the terms of his bid. Bids shall be marked as to indicate: "Name of Bidder: Bid for Kittson County Ditch No. 21 – Diversion 1 to be opened November 3, 2017 at 8:00 a.m."

The Two Rivers Watershed District reserves the right to hold all bids for a period of 30 days after the date fixed for the opening thereof and to reject any bid, or bids, or all bids and to waive any irregularities. No bidder may withdraw his bid within 30 days after the actual date of the opening thereof.
