**NOTICE OF HEARING ON THE IMPROVEMENT OF KITTSON  
COUNTY DITCH #13 IN KITTSON COUNTY, MINNESOTA**

NOTICE IS HEREBY GIVEN that on **August 6, 2026, at 8:00 o'clock a.m.** in the upstairs Meeting Room of the Kittson County Courthouse located at 410 South 5<sup>th</sup> Street in Hallock, Minnesota, a public hearing will be held regarding a pending action of the Board of Managers of the Two Rivers Watershed District regarding the petition for improvement of Kittson County Ditch #13 located in Kittson County, Minnesota.

That said proceeding considers the improvement of Kittson County Ditch #13, affecting parts of Clow, Hill and Hampden Townships in Kittson County, MN. The purpose of the project is to improve drainage along the 4.5 miles of the beginning in the SW ¼ of section 31 Clow Township and terminating in the North Branch Two Rivers in the NW ¼ of section 30 of Hampden Township . The petitioners state that County Ditch 13 is inadequate to support beneficial drainage for current farming and drainage practices, has insufficient capacity, and needs culvert replacements and enlargement to furnish sufficient capacity.

The Viewer's Report and the Engineer's Final Survey Report have been filed with the Board of Managers. Said petition and reports are available for inspection at the office of the Two Rivers Watershed District at 410 South 5<sup>th</sup> Street, Suite 112 in Hallock, Minnesota.

All parties interested in the proposed improvement or who are affected by said improvement are invited to appear before the Board of Managers at such time and place and present their objections, if any, why an Order should not be made by the Board of Managers of the Two Rivers Watershed District to improve Kittson County Ditch #13, located in Kittson County, Minnesota. Alternatively, signed, written comments can be submitted prior to the date of the hearing at the District office, located at 410 S. 5<sup>th</sup> Street, Suite 112, Hallock, MN. Signed, written comments may also be mailed to the above address but must be postmarked prior to 8/6/26.
